Our goal is to increase positive behaviors and feelings in our campers such as increased self-esteem, increased verbalization of feelings, more helping behaviors, and more positive attitudes. We also aim to decrease negative feelings and behaviors such as depression, risk-taking behaviors, and inappropriate expressions of emotions.

4b (Code: ) (Expenses \$ including grants of \$ ) (Revenue \$ ) HIS KIDS for the Holiday Program includes a variety of holiday services for needy families with children with cancer. We provide gift cards for Thanksgiving and Christmas meal purchases, holiday food pantry access to families, miniture Christmas trees for local pediatric oncology treatment centers, and gifts for children ages 0 - 18. We also provide a large family support event including lunch, Santa visits, toy donations to children, activities, and entertainment.

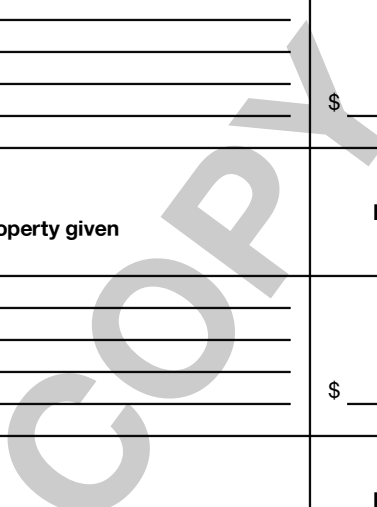
